CASE HISTORIES

Case History # 1

BAE was added at a rate of 4 gallons twice per week to the anaerobic digester of a 5.5 MGD plant. Within two weeks, the floatable cover was at maximum height, & the generator was operating at 100%. At 4 weeks, the boiler was online and occasional flaring was detected. Gas production increased by 28% despite an influent decline of 220,000 GPD.

Case History # 2

This plant operated at 50% above design capacity with a single stage 600,000 liter anaerobic digester. The digester was treated with 500 pounds of lime per week to maintain a 6.7 ph, and sludge was shipped at 3,300 liters per day. Gas production was marginal, requiring winter supplement. At a rate of 1 gallon per day, in just 2 weeks, BAE reduced sludge hauling to 1600 liters per day, lime treatment to 0 lbs. per week, and gas production became copious.

Case History # 3

A 3 MGD plant land-applied its sludge, and the digester often fell short of regulatory requirements by operating between 35-40% VSD. With 2 gallons per day of BAE added to the digester, VSD rose to the 60 – 65% range. Sludge odor was eliminated, gas production increased, & sludge volume was reduced from 9,400 gallons to 6,750 gallons per day, a 28% reduction.

Case History # 4

A single stage 500,000 gallon digester with no combustible gas, circulation, or heating was acting essentially as a holding tank. Sludge was trucked 7-times per week at 7,500 gallons per load. BAE was added at 1 gallon per day and within 7-weeks methane was present in the sludge, and after 20 weeks sludge shipments were reduced from 7-times to 2-times per week, a 37,500 gallon reduction.

Case History # 5

BAE was added to a farm built digester at a dairy farm with 1,000 cows at the rate of 1 gallon per day. Within a few short weeks, the VSD rose from 21% to 36%, resulting in a 71% increase in gas production and reducing organic solids in the digester by 19%.

Case History # 6

BAE was added at a low rate to a farm-built digester to treat the manure of 11,000 hogs. The VSD rose from 41% to 63%, which increased digester gas by 54% and lowered organic loading in the sludge by 37%. This impact enabled the addition of a second electric generator, and excess electricity was sold to the power grid.
